The Hawai'i Pacific University Master's Social Work program prepares students for advanced level social work practice and to sit for professional licensure. ASWB is the regulatory organization for social work licensure. Licensure requires graduation from a nationally accredited master's program and passing an examination. Graduation from the program does not guarantee a license.

The requirements to obtain a master's level social work license differ by state. A "Yes" in the second column indicates that the program meets the *educational* requirements in that state. In addition, each state may have multiple other requirements that must be met. For the states in which you plan to practice, please go to the state social work regulatory website to review the licensure requirements. Because the licensure requirements are subject to change, it is essential that all prospective licensees visit the state social work regulatory website on a regular basis for updated information.
