***If you cannot utilize HPU Pipeline to submit your grades, you must contact your administrative assistant in your academic division, no later than Tuesday, August 21st, 2018. Please remember that the Help Desk in Information Technology will be available Monday-Friday, 8:00 a.m. to 5:00 p.m.**

Please use the steps below when submitting grades.

(For detailed step-by-step instructions, please see reverse side.)

- ☐ STEP 1 **Test your access & log on to HPU Pipeline.**
 - Refer to your Web for Faculty Services User Manual.
 - Contact the Help Desk if you encounter any technical problems.
- ☐ STEP 2 **Assign a grade for EACH STUDENT using HPU Pipeline.**
 - Select and enter final grades only. You will only see the eligible grades that may be assigned for each student.
 - Please note that some courses are graded on a pass/fail or credit/no credit basis.
- ☐ STEP 3 **Enter the last date of attendance.** (Use the correct date format.)
 - Only for students who never attended or did not complete the session.
 - An incorrect date format will delete all grades following that entry.

MM/DD/YYYY example: 05/20/2018
- ☐ STEP 4 **Double check that NO grades are left blank.**
- ☐ STEP 5 **Click on “Submit” button after entering grades.**
 - Remember to “submit” after each page.
- ☐ STEP 6 **Check for a second page.**
 - Assign a grade for each student.
 - Click on “Submit” button after entering grades.
- ☐ STEP 7 **Double check grades submitted.**
 - Verify each student’s grade for accuracy.
 - View assigned grades via your Summary Class List on Pipeline.
 - Make any necessary changes and repeat from Step 5.

PROCEDURES FOR ENTERING GRADES

Please read carefully.

(Detailed Step-by-Step Instructions)

(STEP 1) Grades will be assigned directly by you via the web using HPU Pipeline. You should have already received a *Web for Faculty Services User Manual* from your respective Dean. If not, please contact your academic division to request this material.

(STEP 2) Assign the appropriate grade to each student by selecting "Final Grades" on your Faculty Services Main Menu in HPU Pipeline. Please note that you will only see the eligible grades allowed for each student on your roster. There are cases that a student may take a course on a credit/no credit option or even as an auditor.

The standard Undergraduate course grades you can assign for all other courses are:

A, A-, B+, B, B-, C+, C, C-, D+, D, F, or I

The standard Graduate course grades are: **A, A-, B+, B, B-, C+, C, F, or I (No C-, D+, or D)**

Pass/Fail courses: P or F

Credit/No Credit: CR/NC

Audit: AU

(STEP 3) For those students who never attended or stopped attending your course: **1) issue the student a grade, 2) indicate the last date of attendance in the "Last Attended Date" column (MM/DD/YYYY)**. If you do not use the proper date format, all grades following the incorrect entry may be deleted.

(STEP 4) Make sure that there are **no blanks** in the "grade" column. When entering grades, click on the "Submit" button after each page.

(STEP 5) Remember to check for a second page for additional student records. If you have a second page, assign a grade for each student and click on the "Submit" button.

(STEP 6) Please verify each student's grade for accuracy to be sure that you have entered the grade you want your student to receive. To verify your grades, simply view them via your Summary Class List on Pipeline.

(NOTES) **ACADEMIC DISHONESTY:** Those students receiving a grade of "F" for academic dishonesty should also be reported to the Provost and Dean of Students along with an explanation of circumstances.

NOT ON ROSTER: If you have a student in your class whose name does not appear on the grade sheet, please know that he or she is not officially registered for your course and will not receive a grade at this time. To notify us, we ask that you submit a signed "Change of Grade Form" directly to the Registrar's Office so that we may look into the matter further.

WITHDRAWN: Students who have officially withdrawn will have a "W" grade already assigned. If a student has informed you that he or she has withdrawn and the name still appears on your grade sheet, you must assign a letter grade for that student. *Instructors cannot assign a "W" grade.*

INCOMPLETE GRADE: Use the "I" (Incomplete) grade judiciously. This grade should not be given in lieu of a failing grade. The student should have a legitimate reason to postpone the completion of the class. Each "I" grade will carry a six-month deadline by which the student must complete all course requirements. Any "I" grades at that time will be converted to an "F" grade.
