

## 24-MONTH STEM OPT EXTENSION CHECKLIST

### REMINDER

The Office of International Students and Scholars must update your I-20 to reflect our support of your petition to file for the STEM OPT Extension. It is your responsibility to complete the required application and submit it in a timely manner to USCIS. **Your application must be received by USCIS before your OPT EAD expires and within 60 days of the issuance of the Form I-20.**

***We highly recommend typing the forms instead of completing them by hand. If you do complete the forms by hand you must use black ink.***

### USCIS Application Checklist

Assemble application materials for mailing to USCIS. Paperclip the check/money order and passport photos on top.

- ☐ **Government/USCIS OPT filing fee of \$410.00** (check the filing fee amount here: [uscis.gov/i-765](https://uscis.gov/i-765))
  - o Payable to "The U.S. Department of Homeland Security"
  - o Write your I-94 number and date of birth on the memo portion of the check/money order
  - o Check/money order must have a printed or handwritten name and address
  - o You can pay with a U.S. credit card using: [uscis.gov/g-1450](https://uscis.gov/g-1450)
- ☐ **Two (2) U.S. passport-style photos** (taken within the past 30 days)
  - o Lightly print your name and I-94 number on the back of each photo
  - o See passport photo guidelines explained on page 20 of Form I-765 Instructions: [uscis.gov/i-765 PDF](https://uscis.gov/i-765)
- ☐ **Form G-1145:** [uscis.gov/g-1145](https://uscis.gov/g-1145)
- ☐ **Original, signed Form I-765:** [uscis.gov/i-765](https://uscis.gov/i-765)
  - o At the top, mark: Renewal of my permission to accept employment
  - o Item 27: Eligibility Category is (c) (3) (C) [small c, number 3, capital C]
  - o Item 28.a.: Degree is listed on page 1 of I-20 under Major
  - o Item 28.b. and 28.c.: Please obtain this information from your employer
  - o Signature: Use black ink to sign name on the signature line, keep signature within the box
- ☐ **Form I-983 Training Plan:** [studyinthestates.dhs.gov/form-i-983-overview](https://studyinthestates.dhs.gov/form-i-983-overview)
  - o Must include employer's Employer Identification Number (EIN)
  - o Your DSO is Bernard Chong ([bchong@hpu.edu](mailto:bchong@hpu.edu)) - you may use the OISS phone number: (808) 356-5299
- ☐ **Photocopy pages 1 and 2 of complete STEM OPT Extension I-20 and previous I-20s**
  - o Please sign and date page 1
- ☐ **Printout of I-94 arrival/departure form** (or if you have a paper I-94, include front and back): [i94.cbp.dhs.gov/i94](https://i94.cbp.dhs.gov/i94)
- ☐ **Photocopy of biographical page in passport**
  - o Must be valid for at least 6 months prior to the application date
- ☐ **Photocopy of F-1 visa** (except citizens of Canada and Bermuda)
- ☐ **Photocopy of all previously issued EAD cards** (front and back copy) **and OPT I-20s** (page 1 and 2)
- ☐ **Verification of graduation from HPU** (proof of STEM degree)
  - o Official final transcript (preferred) or photocopy of your diploma showing the STEM major and degree level that makes you eligible for the STEM OPT Extension

## ***Mailing Instructions***

1. Make copies of the entire application for your records and mail your original application via certified U.S. mail (or through a courier service). It is recommended to send your application with a tracking number. Application must be received by USCIS before your post completion OPT EAD expires and within 60 days of the issuance of the Form I-20.
2. Mail the application to the USCIS Lockbox for the state you currently live in:

## ***Additional Information***

- Students who file the STEM OPT Extension application in a timely manner will be able to continue employment until a final decision is made by USCIS or for 180 days, whichever is earlier
- OISS advises students not to travel until the STEM OPT Extension application is approved and a new EAD card has been received

**Note:** If you do not receive your EAD card after 90 days of your 'notice date' as printed on the Notice of Action (Form I-797) from USCIS, please contact OISS. **If you LOSE your EAD card, you must file an Application for Replacement AND pay another \$410.00 filing fee.**
